Trustee's In Transition

Ensure Treatment within the Exclusive Provider Network (EPO) We've been receiving requests for assistance from contractors and claims adjusters regarding unauthorized treatments occurring outside the Exclusive Provider Organization (EPO). This often stems from a lack of communication to the injured worker about the necessity of seeking care within the EPO.



How can you prevent similar issues?

1. Inform Your Employees:

Distribute the 'Union Émployee's Guide' brochure to all Union members annually, during onboarding, and especially when an injury happens.

- Download the guide from our website: Union Employee's Guide
- Request FREE glossy tri-fold brochures from our office.

2. Choose an Occupational Medicine Clinic for Injury Care:

Select a designated clinic for work-related injuries. Utilize these resources:

- Identifying a Designated Medical Care Provider
- Establishing a Designated Provider Relationship
- Designated Provider Map Template

3. Remove Barriers to Successful Return-to-Work:

Use the following resources to help facilitate a smooth return:

- How to Get a Return-to-Work in 3 Days
- Ensure a Successful Return to Work through Light Duty
- What a Union Member Loses on Work Comp

By taking these steps, you can help avoid complications and ensure compliance with EPO requirements.

Exclusive Rehabilitation Consultant (QRC) Network Update

The UCWCP's Exclusive Rehabilitation Consultant network of experienced Qualified Rehabilitation Consultants (QRCs) are reviewed annually to ensure injured Union members, and their employers continue to receive the best delivery of statutory rehabilitation services.

The Trustees want to ensure that injured Union members receive appropriate and expedited medical treatment; that all the parties to the injury receive timely information regarding medical and vocational status; that a prompt and safe return to Union work, wages and benefits is achieved whenever possible; and, if a return to the trade is no longer possible, that assistance is provided to allow for a successful transition into other gainful employment.

In September, the Trustees reviewed 2023 QRC data gathered by the Program as well as considered new QRC applicants to join the network. 
