UCWCP Celebrates 25 Years!

Beginning with the idea that labor union leaders and their members, along with employer associations and their members, could create a workers' compensation system that would focus on a 'win-win' for both parties, the *Union Construction*

Workers Compensation Program (UCWCP) was built.

With the participation of four trade unions, two employer associations and four employers, the Program began operations in July 1, 1997.

Today, the UCWCP has all basic and specialty trade unions participating statewide, along with all employer associations that represent construction companies. 375 construction companies participate, employing an average of 22,000 skilled union trade workers throughout Minnesota, who earn \$1.4 billion dollars annually of field payroll.

The greatest obstacle was identifying and communicating to both labor and management that their existed an outcome that served their mutual interests - a true 'win-win'. The focus was on the big picture - what can the UCWCP do to assist injured participants returning to their pre-injury job with union wages and fringe benefits quickly and safely.



Contractor Member Subscription Fees for July 1, 2022 to June 30, 2022: No Change!

Due to the Program's continued growth, the Board of Trustees approved **NO CHANGE** to the formula for calculating employer contribution. For the fiscal year: 2021 calendar-year union labor payroll multiplied by .0012. There is a minimum Assessed payroll of \$800,000 (resulting in a minimum annual fee of \$960). There is a maximum Assessed payroll of \$8,291,667 (resulting in a maximum annual fee of \$9,950). Only payroll of employees who are members of participating unions is used for the calculation.



The Union Construction Workers' Compensation Program informs, assists and empowers injured union employees and employer members by:

- Providing information about what to do when an injury occurs;
- Identifying an appropriate medical provider in the Exclusive Provider Organization (EPO);
- Contacting claim adjusters and other parties to resolve a dispute;
- Responding to questions pertaining to insurers, employees' and employers' responsibilities under MN workers compensation;
- Helping injured employees and employer members overcome barriers to return to work.
