Important Update: Concentra Medical Center Acquires MN Occupational Health in Minnesota

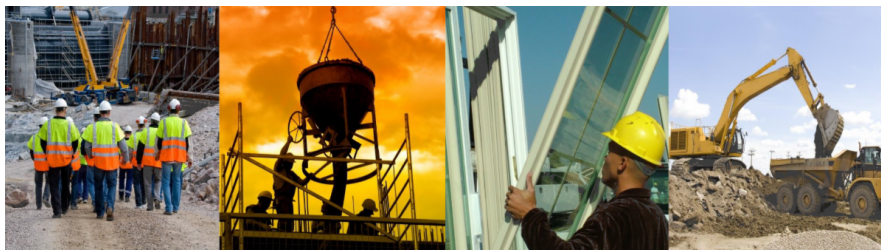
Effective August 17, 2026, the following former MOH locations will open as Concentra medical centers:

- **Concentra Coon Rapids at 600 Coon Rapids Boulevard NE, Suite 2, Coon Rapids, Minnesota 55433**
- **Concentra Eagan at 1400 Corporate Center Curve, Suites 110, 120, & 200, Eagan, Minnesota 55121**
- **Concentra St. Paul – Midway at 1661 Saint Anthony Avenue, Saint Paul, Minnesota 55104**
- **Concentra Shakopee at 4360 12th Avenue East, Shakopee, Minnesota 55379**

These medical centers will provide an additional access point to Concentra for occupational health services in Minnesota, including a full offering of occupational medicine, urgent care, and physical therapy services. The facilities include digital X-ray, multiple exam rooms, and large physical therapy space.

Membership Dues for July 1, 2026 - June 30, 2027: No Change!

Due to the Program's continues growth, the Board of Trustees has approved no change to the formula used to calculate membership dues for the upcoming fiscal year.

For July 1, 2026 through June 30, 2027, dues will continue to be calculated as follows:

$$\text{2025 calendar-year union labor payroll} \times 0.00115$$

The minimum fee remains **\$960**, and the maximum fee remains **\$9,950**.

As a reminder, only payroll for employees who are members of participating unions should be included in the calculation.

Satisfaction Survey Reminder

The UCWCP is committed to delivering the highest quality services to injured Union member, employer members, and claim administrators. To ensure we meet this goal, we regularly assess satisfaction through post-service surveys.

Surveys are sent after the following activities:

Dispute Resolution Services

After a Mediation, Arbitration, or Dispute Resolution Exam, surveys are sent to the injured Union member, employer, and claim administrator. These surveys gather feedback on the overall process and the performance of the Mediator, Arbitrator, or Neutral Physician.

Statutory Vocational Rehabilitation Services

When statutory rehabilitation services are completed, surveys are sent to the injured Union member, employer, claim administrator, and Qualified Rehabilitation Consultant. The feedback focuses on the quality of services provided throughout the rehabilitation plan.
