## 2019 Items of Interest

- 2019 ended with 366 participating contractors employing 22,497 trades-people earning \$1.3 billion in annual field payrolls.
- The program's average EMR reached a record low of .91 for the group.
- For July 2019-June 2020, Trustees approved <u>no increase</u> to the payroll multiplier used to calculate employer subscription fees. The maximum annual fee was increased (\$9,950) and the minimum annual fee was unchanged (\$960).
- A dedicated UCWCP Member Services phone and email address was created to allow for faster access to any program staff for information and assistance.
- The "Union Employee's Guide" was redesigned and posted on our web site to allow members to add it to a digital handout, or print copies if needed.

### **Trustees in Transition**

Scott Weicht, of Adolfson & Peterson resigned from the board of trustees at our December meeting. Scott helped in the creation of the concept of a labor-management workers' compensation alternative in 1995. He began serving as a founding trustee in 1997. Farewell Scott and thank you for 25 years of service to the organized construction industry and the UCWCP. Best wishes in your retirement.
