Welcome Brendan Moore!

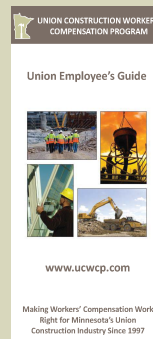

Workers' Compensation MCPAP
Credit Due: April 1, 2023

The Minnesota Premium Adjustment Program (MCPCP) was introduced to level the playing field and add more equity to the pricing of contractors'



The Program Trustees have approved two new individuals to

workers' compensation policies. MCPAP provides premium credit for up to one year for a policy that contains one or more contracting classifications. Employers who paid the qualifying average hourly wage in at least one contracting classification during the calendar year are eligible.

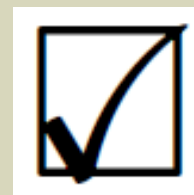
Exclusive Provider Organization (EPO) Updates:

Satisfaction Survey Reminder

The UCWCP assesses the satisfaction of services provided to injured Union members, employer members, and claim administrators to ensure we are providing the best service possible. Surveys are sent following these activities:



Dispute Resolution Services: Following a Mediation, Arbitration or Dispute Resolution Exam, a survey will be sent to the injured Union member, employer and claim administrator requesting feedback on the overall process and services provided by the Mediator, Arbitrator or Neutral Physician.

Statutory Vocational Rehabilitation Services: Following the completion of statutory rehabilitation services, a survey will be sent to the injured Union member, employer, claim administrator and Qualified Rehabilitation Consultant requesting feedback on the services provided during the rehabilitation plan.

Survey results are review by the Program's labor-management Board of Trustees to ensure service outcomes align with the mission of the Program. We appreciate your feedback and assistance in providing the best service possible.
